Acknowledgement:

- I understand that the tuition and fees, exclusive of registration fees, technology fees, PG class collection, 50/50 raffle, and PG dues, will be paid in 11 equal monthly installments due the 1st of each month, beginning July 1, 2020 through May 1, 2021. I also understand that tuition and fees are non-refundable regardless of circumstances or date of withdrawal. For the 2020-2021 academic year, in accordance with Archdiocesan Policy, families are required to pay tuition online through FACTS Management.
- I understand that a late fee of \$25 will be applied to each payment received after the 10th of each month.
- Every family is expected to purchase at least \$2,500 in SCRIP over the course of the school year (approximately \$250 per month), or choose the \$125 buy-out option which is what OLMC would have earned if you participated in the SCRIP Program.
- At OLMC, all students are registered for our Before and Aftercare Programs. Once the service is used, a \$25 fee will be applied to your first bill. A daily fee of \$8.00 per hour will be charged for the first child and \$4.00 per hour for each additional child in the same family. For children who are not picked up by 6:00PM, there will be a late fee of \$10.00 per quarter hour. All hours are calculated from 3:00PM. Before care will be billed at \$6.00 per day. There is no registration fee. Families are billed on the 1st for the month and payment is due by the 10th. Families in arrears for 60 days will not be permitted to use the Program.

(This form can also be downloaded from our school website.) If you wish to enroll a younger child in addition to the child(ren) re-registering, please call the school office. If you reside in a town that offers transportation or funds in lieu of transportation, you can download a B6T form from our website and you must bring it to your town's Board Of Education.

To determine staffing, class size and to finalize the school's budget, it is important that each family commits by February 10, 2020. Enrolment for new families will begin on Tuesday, February 11, 2020.

Catholic education is a worthy investment in the future of our children! I understand that it can be a financial sacrifice, but the rewards are boundless. If there is a need, financial aid may be requested via letter to the school principal.
