It's that time of year again! As our 8th graders and their parents decide on which high school they will attend in September 2021, our PK3 - Grade 7 students and their parents are ready for Re-Registration for the 2021-2022 academic year.

Attached you will find the paperwork needed for the re-registration process. Please complete the form and return it to school no later than Friday February 12th. (This form can also be downloaded from our school website.) If you wish to enroll a younger child in addition to the child(ren) re-registering, please call the school office. If you reside in a town that offers transportation or funds in lieu of transportation, you can either download a B6T form from the OLMC school website or call the office and we will mail a form out to you. Please return the completed form to the school office by March 1st. If the forms are not received by March 1st, entitled families will not receive transportation or funds in lieu of transportation.

To determine staffing, class size and to finalize the school's budget, it is important that each family commits by Friday, February 12, 2021. Enrollment for new students and families will begin on Monday, February 22, 2021.

Catholic education is a worthy investment in the future of our children! I understand that it can be a financial sacrifice, but the rewards are boundless. If there is a need, financial aid may be requested via a letter to the school principal.

- I understand that tuition will be paid in 11 equal monthly installments beginning July 2021 through May 2022. Registration fees are non-refundable regardless of circumstances or date of withdrawal. For the 2021-2022 academic year, in accordance with Archdiocesan Policy, families are required to pay tuition online through **FACTS** Management.
- I understand that a late fee of \$25 will be applied by **FACTS** for payments more than 10 days late.
- At **OLMC**, all students are registered for our Before and Aftercare Programs. Once the service is used, a \$25 fee will be applied to your first bill. A daily fee of \$10.00 per hour will be charged for the first child and \$5.00 per hour for each additional child in the same family. For children who are not picked up by 6:00PM, there will be a late fee of \$10.00 per quarter hour. All hours are calculated from 3:00PM. Before care will be billed at \$6.00 per day. There is no registration fee. Families are billed on the 1st of the month and payment is due by the 10th. Families in arrears for 60 days will not be permitted to use the Program.
